

Exciting changes

We're thrilled to highlight some big changes coming to Aspire Health Plan benefit offerings in 2024, including the introduction of the brand-new Aspire Health Protect plan which is designed to provide affordable prescription drug coverage.



All Part D prescription drug plans for 2024 will feature a \$0 deductible, including the Aspire Health Value and Protect plans. This change ensures that you'll enjoy the convenience of flat co-pays from the first prescription of the year, streamlining your healthcare experience. This means no upfront costs before you start receiving the medications you need, offering you a seamless transition into your prescription drug coverage.

For 2024 we're delighted to share that members will not see an increase in co-pays for all non-specialty medications (all drugs except those covered through tier five), adding another layer of predictability to your healthcare costs.

The Aspire Health Plan team is dedicated to continually improving your healthcare journey. With the addition of the Aspire Health Protect plan and eliminating deductibles for Part D prescription drug plans, we're committed to ensuring that your health and well-being remain our top priorities. Stay tuned for more details, and we hope you take full advantage of these exciting changes ahead.

Good news for members qualifying for Extra Help

The Part D Low Income Subsidy (LIS), also known as Extra Help, provides extra help for people with Medicare who have limited income and resources. LIS helps pay Medicare prescription drug benefit costs (monthly plan premiums, co-payments, and the annual deductible).

Effective January 1, 2024, the Inflation Reduction Act (IRA) will be expanding eligibility for low-income individuals under Part D of the Medicare program. This change means beneficiaries who are currently benefiting from partial LIS benefits will now be eligible for full LIS benefits.

The annual enrollment period is here do you have the right "Protect"ion?



It's that time again: Medicare's annual enrollment period is here. This is a time when Medicare plans adjust benefits and introduce new options, and you have the opportunity to review changes and decide what is right for you. Each of our members has different goals and needs, and we strive to offer options that can meet those individual needs. This year, we are excited to roll out the Aspire Health Protect plan as another path to getting the coverage you want while maximizing affordability.

Aspire Health's new Protect plan is an HMO plan with the same network as our other plans but with a new twist: \$0 monthly premium. In the plan, you will find low and affordable co-pays on the services you use most, like important visits to your primary doctor and specialists. We have also made the unexpected a little more manageable with lower co-pays for urgent care, emergency, and inpatient stays. As you review the changes to your current plan, you will notice that in 2024 we eliminated the deductible on the Part D prescription drug benefits, on all of our plans, including the new Protect plan.

The Protect plan includes all the extra benefits as our other plans, such as transportation, a fitness membership through OnePass[™], chiropractic visits, acupuncture, and the option to add dental, vision, and hearing coverage for a monthly premium.

What's got you sick? why antibiotics are not always the answer



While antibiotics are needed for treating certain infections that are caused by bacteria, they don't work on viruses. Some of the most common ailments we suffer from this time of year, like colds and flus, are not helped by taking antibiotics.

Antibiotics also won't help some common bacterial infections including most cases of bronchitis, many sinus infections, and some ear infections. And taking antibiotics when you have a virus may do more harm than good: you will still feel sick, and you could experience side effects associated with the antibiotic.

Importance of adherence

Aspire Health Plan understands the importance of your health and well-being, so we want to remind you about the significance of adhering to your medications — especially if you're managing conditions like diabetes, hypertension, or high cholesterol. Consistently taking your prescribed medications can greatly impact your quality of life and overall health.

WHY ADHERENCE MATTERS

Managing chronic conditions requires a consistent approach, and taking your medications as prescribed plays a crucial role in controlling your health. Skipping doses or not following your doctor's recommendations can lead to complications, hospitalizations, and a decrease in the effectiveness of your treatment plan. Adhering to your medication regimen can help you lead an active and healthy life.

THE POWER OF EXTENDED SUPPLY

Starting in 2024, Aspire Health Plan's prescription drug benefit will allow you to fill up to a 100-day supply for most maintenance medications. This means fewer trips to the pharmacy and more convenience for you. By filling a three-month supply, you'll only need to pay two co-pays instead of three, saving you money while ensuring you have the medications you need when you need them. Talk to your doctor to see if a 100-day supply would be right for you. If you would like to take advantage of a 100-day supply, have your doctor write you a new prescription allowing the pharmacy to fill a 100-day supply.

Suppose you currently receive a 90-day supply of your medication but would like to increase the quantity you receive with each refill. In that case, you will need to have your prescriber send a new prescription for a 100-day supply to your pharmacy. Contact Aspire Health Plan for more information on switching to a 100-day supply.



SMART STRATEGIES FOR ADHERENCE

Aside from extended supply options, there are other strategies to help you stay on track:

- Refill reminder programs: sign up for refill reminder programs with your pharmacy. Many of these programs offer text messaging services, making it easier to receive notifications about when it's time to refill your medications
- Medication organizers: use a pill organizer to help keep track of your daily medications. This simple tool can prevent confusion and missed doses
- Routine integration: incorporate your medication routine into a daily habit, like brushing your teeth or having a meal. This makes it less likely to forget your doses

By staying adherent to your medications, you're taking proactive steps toward a healthier, happier life. If you have any questions or concerns about your medications, including difficulty paying for your prescriptions, don't hesitate to call Aspire Health Plan for more information.
